For product distribution and use, the three geographical regions (D & F) are distinguished.

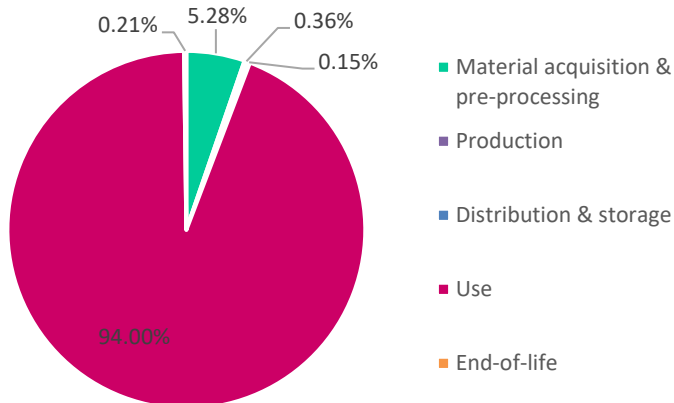

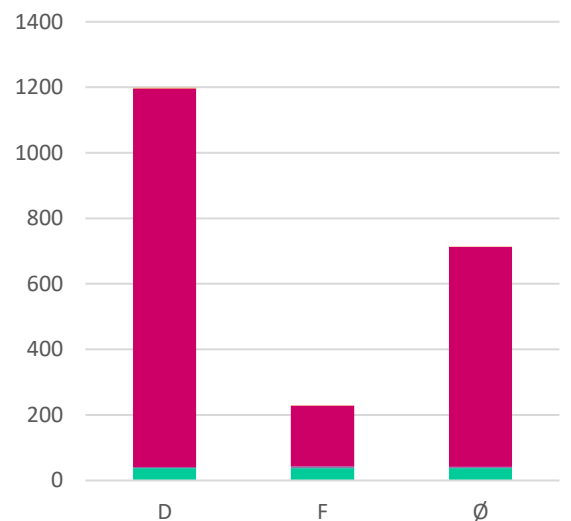

## Update record
